The WAVE Network

The WAVE Network was established in 1994 as a network of women's NGOs and specialist women's support services (women's shelters, women's centers, intervention centers, helplines and other services). The main objective of WAVE is to work towards elimination of all forms of discrimination and violence against women and their children and to promote the right of women and girls to live free from violence in both the public and the private sphere and to promote the human rights of women and girls.

The WAVE office serves as a linchpin for the whole network of WAVE.

The WAVE Network is comprised of **161 Members** (Aug. 2020), located throughout 46 European countries. Through these Members, together with the extensive WAVE online database, the network reaches out to more than 4,000 women's organizations across Europe. The members of WAVE include women's organizations, individuals and networks working to end violence against women and their children. Additionally, honorary membership can be granted. Prof. Dr. Carol Hagemann-White is the first honorary member of WAVE.
